\$350 for Varsity Boy's Duals.

*Teams that attend ALL 3 Mad Ranch Tournaments will be given a discounted rate of \$900 for ALL 3.

*Teams that attend 2 out of the 3 Mad Ranch Tournaments will be given a \$50 discount off the team rate.

Teams: Contracts Due by October 29, 2021. Payments Due by December 1, 2021. Bring as many wrestlers as you would like. Accepted varsity team list will be announced.

Format: Duals: 16-Team Pooled Rotational – 8 mats:

- Each team will have 5 duals.
- Teams will be divided into 3 pools of 4 teams. (3 Duals)
- Teams will then be placed in brackets according to pool placement. (2 Duals)

JV: Individual Bracketed tournament – 6 mats:

- Semi-finals loss wrestles for 3rd & 4th.
- Consolation wrestles for 5th.

Awards: Duals: Team Champions will earn a Champions Banner. The following teams will receive a Plaque: 2nd, 3rd, and Winner of the Silver Division. JV: Medals for Top 6 per weight.
